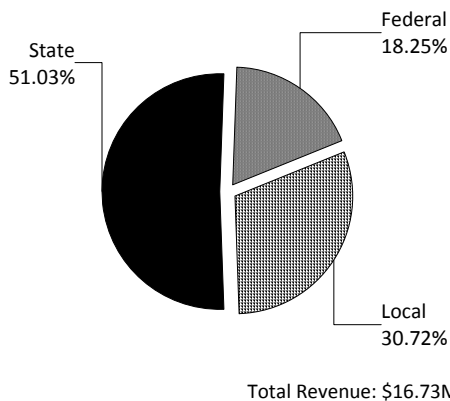

Revenue Sources



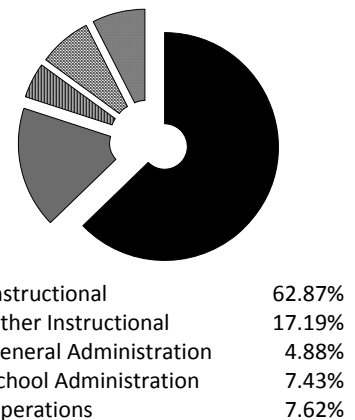
