COAT

FABRIC: Sapphire Blue, Raven Black and Sublimated Divine White

100% Synthetic Xtreme Dri Fabric

STYLE: Full construction waist length coat, bottom point offset to left, with back cut straight.

<u>CLOSURE:</u> Full length center back YKK heavy duty Vislon zipper.

SPECIAL DETAILS: Athletic fit patterning. Fully constructed coat that allows the coat to be professionally laundered/machine washed or professionally dry cleaned. The coat has performance-wear "Aerocool" lining for maximum breathability and comfort for the wearer. "Aerocool" lining is woven to absorb and evaporate moisture rapidly by capillary effect. The absorption, diffusion and evaporation system of this lining is designed to maintain cool body temperature and excellent comfort for the wearer. The coat also utilizes performancewear canvas that is fully machine-washable. The coat has snap tape (manufactured in-house for quality control) at the cuffs to allow for adjustable hems without the necessity of sewing. The sleeves are a special pattern that allow freedom of movement for the wearer. There are special pre-molded (3/4" thick) firm foam shoulder pads with nylon tricot covering measuring 5" wide x 9" long at each shoulder. The "Comfort Collar" utilizes eight layers of construction. The collar lining is Xtreme Dri fabric and has a non-woven material, permanently sewn and bonded to the inside. It is sewn directly to the inboard surface of this tandem collar lining construction, centered on the lining and running the circumference of the collar are two layers of 1/2" horse-hair braid reinforcement. The outer collar shell, also made of Xtreme Dri, has a non-woven material permanently sewn and bonded to the inside. Both the collar lining construction and the outer collar shell construction are sewn to two base layers of heavy duty Pellon forming the finished comfort collar. Each coat has an identification number, as well as a barcode.

FRONT TRIM: Custom sublimation on Xtreme Dri Divine White in shades of Sunsplash Yellow, Sapphire Blue, and Black. Gold Glamorous applique sewn into curved insert seam.

SHOULDER CAPS: Xtreme Dri Raven Black self-lined on right. Left cap is Xtreme Dri Sapphire Blue self-lined.

BACK TRIM: Xtreme Dri Raven Black with no trim.

<u>COMFORT COLLAR:</u> Xtreme Dri Sapphire Blue on the left front. Xtreme Dri Raven Black on the remaining parts. Collar is lined with Xtreme Dri Raven Black. Special lap over on right side with a 30L Gilt Dome tack back button.

SHOULDER STRAPS: None.

<u>SLEEVES:</u> 50/50 patterned sleeves with Xtreme Dri Sapphire Blue on the right sleeve. Left sleeve is Xtreme Dri Raven Black. Right sleeve has a special 3" school font logo "QUITMAN" and "BIG BLUE CREW" of White Direct Swiss stitching.

DESIGN SPECIFICATIONS

JUMPSUIT

FABRIC: Raven Black 100% Synthetic Xtreme Dri Fabric

STRIPE: None

SPECIAL FEATURES AND DETAILS: Special Racer Back style with athletic fit pattern. Identification numbers and barcode. 1 ¼" shoulder straps of matching jumpsuit fabric with nylon slides and black elastic in back of suspenders for wearer's comfort. Inseam sewn with 5/8" seams for let out. 4-way reinforced crotch. 3" let-out in center back. Snap tape is on back of seam allowance on the out seam and it is on the front side of the seam allowance on the inseam. Stitched permanent crease. Welted pocket on one side of front.

ACCESSORIES

<u>SHAKO</u>: Flat top design with plume holder center front that is reinforced with a screw post and nut. Gold molded plastic visor. The top, back, and bottom band are Xtreme Dri Raven Black. Front is Xtreme Dri Sapphire Blue. Gold SM-900 with extra triangle, pointing down is centered on front. Clear plastic chinstrap with Gilt buckle. Xtreme Dri Raven Black front strap. Grommet at each end of strap. Separating prong back buttons at each lower side. There is a metal hook in the back of the shako for the chinstrap to rest on. The cord inside the shako for adjustability does not tie but has a special cord lock for ease of use and added security.

PLUMES: 14" Black French Upright with Sunsplash Yellow interspersed and Gilt cup.

GAUNTLET CUFFS: Right cuff to be Xtreme Dri Sapphire Blue, self-lined with a insert fin of Gold Glamorous. Left cuff to be Xtreme Dri Raven Black, self-lined with a insert fin of Gold Glamorous. One 30L Gilt Dome tack back button set at edge of Blue and Black. Velcro closure. Special gusset of matching fabric on each opening edge to prevent the Velcro from contacting the coat sleeve.

SHAKO BOX: Shako-Mate style in black high impact polystyrene.

GARMENT BAG: "The Protector" - 600 Denier heavy duty polyester with PVC waterproof liner. Reinforced zipper stops. Clear viewing window. Reinforced, durable hanger opening. Super-sized (16" x 24") zippered utility pocket. Metal grommet reinforced air vent. 1" wide poly web carrying strap. Velcro closure at top to secure hanger. Handles at top and bottom of bag to carry as a fold over bag.

HANGER: Black plastic wishbone style to be included with each uniform.

<u>UNIFORM MANGEMENT SYSTEM:</u> UMS system that is "cloud" or "web" based and is accessible with any desktop or laptop computer or any handheld device wherever an internet connection is available. It easily assigns uniforms based on just a few measurements or pieces of information. It is easily accessible with login and password that can be adjusted and changed by the user. The UMS system is free of any yearly charges or fees.
